350th Planning Team

Citizens from all walks of life, met from April through November at City Hall Alder Chambers agreeing to a Year-Round Celebration - something each month. We have an opportunity to apply to grants offered by the Valley Community Foundation; and, in our November meeting, we were directed to apply to two grants based on our Proposed Year-Long Plan. One grant is upwards to \$50K. Please see our June - November, Special Meetings Minutes, uploaded to the City dashboard, for a full understanding. We are holding off on Meetings at the Direction of the Mayor as he assembles the Committee.

<u>Art</u>

Since 2019, we've enjoyed a strong dialogue towards the presence of sculptures, murals, busts in Derby working with Rise Up, CT Murls. For 9 months, The Cultural, Economic Development and Rise UP Arts met and developed a Presentation on the Derby Middle School Building MURAL Opportunity. Please note that in terms of resources - The Artists and supplies would be independently financed by the school as per Principal, Rachael Caggiano. This February 8th,



we are to be on the Agenda with our Presentation. Our Superintendent Matt Conway supports this effort.

Beautification

The Derby Cultural Commission has successfully worked with both Public Works and Home Depot in Community Wide Clean-Ups; and, we hope for the same this year - engaging both the community and students. We received a terrific response via Social Media as to our suggested Pizza Party Clean-Ups in each neighborhood. Normally the City sponsors one annual City-Wide Clean-Up with the assistance of Public Works and Home Depot. The Cultural assists with these and also in between these times having beautified Irving Elementary School; Elizabeth Street; Water Street; Caroline Street; Derby Green and more. We hope to join Friends of Derby Public Library. We identify areas to rake leaves; nip fading buds; pick up trash and/or plant donated flowers. We are planning a Spring 2024 Focus, seeking to collaborate with Home Depot for Irving Elementary School Begonia Planting.

Christmas Holiday Photography Contest

In December/January, Seven Residents participated in this event; and, those beautiful pictures are posted on: "The Derby Cultural Commission, Facebook Site". The Cultural sought donations from our wonderful merchants and prizes were awarded. No expenditures required.

The City of Derby Departments also participated; and, they were Human Resources & Finance. January 2024 saw a dazzling Social Media Demographics earned 8259 Engagements demonstrate how vested the Community feels towards their Town's Beauty.

Downtown Merchant Association Proposal

In our work meetings for a few years with our wonderful area Merchants to secure event donations, we enjoy an enriching dialogue. We should relay that some Merchants are enthusiastic to collectively have their concerns represented for quarterly meetings at City Hall. Merchants were not adverse to a yearly Downtown Merchant Association Fee of \$250.00. We have studied some CT. Cities who already have these Associations in place. (Funds could go towards "A Taste of Derby." We believe Merchants could have a Voice that would ultimately enhance efforts towards Revitalization and Tourism success. As one example, we worked with Economic Development; and, 'together', we were instrumental in supporting Scoot & Paddle business venture on O'Sullivan Island. This January, we worked with "More Than Hair' whom expressed their goal of increasing business via Community Involvement and through our discussions - they were able to offer DISCOUNTED fees to the Pop Warner Cheer Team.



Flag Raisings

No January Activity. Since 2021, Derby has received favorable News Coverage with City Hall Cultural Flag Raisings. The Channel 12 News Crew arrived for our Pride Flag Raising and also the New Haven Register featured reporter arrived for our Mexican Flag Raising. Further we received tremendous outpouring of positive feedback with our Ramadan Flag Raising from the area Muslim Community. Our Seasons include our new residents and their flags so far included are: Irish Flag; Mexican Flag, Ramdan Flag; Pride Flag; ; Israel Flag and Italian Flag. We've been THE sole CT City to observe international flag raising all year. The positive impact on our area residents AND new students cannot be underestimated with resounding appreciation and joy expressed from new residents missing their homeland and seeking acceptance and recognition here. The costs are minimal with \$35.00 investment for a Cultural Flag. We did a live stream directly to Derby High School, geography and social studies classes. This tradition cumulates for Derby Day's International Fashion Show and Flags Celebration. The next event to be scheduled is the Irish Flag Raising planned for St. Patrick's Day with Irish Dancers; and, resident cultural flags are always considered as time permits

Finance - February 2024

Having no expenses since the Tree Lighting, figures should remain same from last reporting period:

Finance Outlook - Capital Planning, 2024-2025

We seek an increase to our Annual \$10K Budget with specifics in Capital Planing Report to City Staff. We successfully held a Full Calendar Year of 2023 Events while keeping a Net Income into Year 2024! Towards working to decrease our costs we have accomplished the following in 2023. Solicited Donations from Local Merchants; Merged Seasonal Easter/Halloween Events with other City Departments; Found 'some' Concert Bands who can perform for under \$400.00. (Most are \$800.00 to \$1000.00 and have a huge following.) Yet, we require a stable, budget.

We believe with the upcoming Derby 350th Birthday Party in 2025 as well as rising costs, an annual budget increase is warranted. Please review our Facebook Page and Minutes to understand the positive impact Culture has on our residents well-being and Economic Growth and Tourism.

July 4th, 2nd Annual, Patriotic Essay Contest Awards' Celebration

This is our second year as Colleagues with both The Catholic War Veterans, Post 1562 and Derby Middle School/St. Mary's School. We meet each month to plan the contest content, judge submissions and plan logistics for the event to be held on the Derby Green. We met this past



January planning the contest and outreach for participants. The Contest was very well received by Students and their Families as well as the general public where we embodied community-wide participation from area church bell tolling, Derby Historical Society Speakers to planned Police Flag Ceremony and so much more on this most Patriotic Day. Permission for the July 4th event in the Derby Green is being secured and Letters seeking Donors and Participants are going out this month.

Meetings/Minute

Meeting~ We normally hold our Meetings in-person and via Zoom at City Hall, at 7 PM, the last Monday of each Month. Please see the Dashboard for all Minutes uploaded including Audio & Video. This includes both the Derby Cultural Commission Regular Meetings & Special Meetings (350 Planning).

Seasonal

In December, we met with Business Owners of Furniture whom are from Egypt. They shared with us their Christmas Season celebration of December 27th, which we were pleased to recognize on Social Medial. Also, We are pleased to have a repertoire with the Asian Business and Resident Community. In one dialogue we had an opportunity to meet a future Asian Family whom expresses their interest in relocating to Derby having cultural support in terms of Business as well as the Chinese Student Exchange Program here in Derby - we will be celebrating the Chinese New Year for February 10th. We enjoyed recognizing Martin Luther King Birthday via Social Media; and, we plan to display via Social Media, our Student Art Winners for Black History Month. It is THE critical time to begin advertising and recruiting Vendors for Derby Day 2024; and, planning that date!

Social Media

Our Facebook Site had 36 new followers for the Month of January; and, this brings us to ~1000 Followers. We are excited as demographics show our audience consists of not only Derby residents but also Ansonia, Shelton, Seymour, Stratford, New Haven, Bridgeport, Waterbury, Stamford as well as the surprise of foreign countries like Mexico, Educador, Bahrain. We continue to promote all Derby business and restaurants towards outreach throughout Connecticut via Social Media. We consider social media as one of the many Tourism Outreach efforts to draw attention to our CT Magazine award-winning restaurants, our Derby Greenway of over 100K visitors per year as well as our recreational facilities like Payden; our new fishing pier and Osborndale State Park and our 4th Year of Scoot & Paddle Rentals' Resource. We enjoy mutually beneficial relations and support events with Cultural Commissions of Ansonia, Seymour, Stamford, Waterbury as well as the Valley Regional Chamber of Commerce.



Summer Concert Series

By this February, we would begin to line up Performers for June through September Concerts. Both Town Clerk Marc Garofalo and myself have planned these.

We recommend a budget increase as Performer fees have dramatically risen, at times those costs have taken over 85% of our Annual \$10,000.00 Budget and see the 2022 Concert Budget. Bands currently are reaching out now to secure a Summer Schedule.

Main Street South site Re-Use/development project:

- Route 34 Main Street widening progressing on plan (Luchs Engineering providing project management
- Urban Act Fund grant obtained by NVCOG (original award for \$5M) for Main Street South infrastructure (including scrap yard relocation). Further \$50,000 grant obtained by NVCOG for scrapyard remediation
- Status of Relocation & remediation of scrap metal business:
 DECD \$915k grant approved, terms agreed with land owners require CITY ARPA 1/3rd match (\$435k). City Attorney(s) reviewing negotiated sale agreement.

O'Sullivan's Island Recreational area

- BoAA approved use of ARPA funds (not to exceed \$500k) for the Greenway bridge repair. ATANE (state approved vendor) contacted and start date for Engineering Review being determined
- Fishing Pier and Scoot & Paddle rental create visitor appeal. Our Greenway user stats for 2023 show 233,056 (YTD) and 802 (third quarter) as our numbers for the 3 quarters. So, we are now second in CT rather than first, (Groton) but those are still very impressive numbers. Preparation of Recreational trails grant application to provide Greenway lighting under review.

Derby Housing Plan

- Draft Derby Housing Plan completed by Luchs Engineering
- Planning & Zoning commission discussed of Draft Derby Housing Plan at January P&Z meeting. Presentation to BoAA required

<u>Derby Parking Garage - stabilization and restoration</u>

 Further Upgrading of LED lighting and surveillance system completed, some repairs made Free of Charge by DFG Electric

Expansion of Derby Landfill (1.5MW-4.0 MW) ground based Solar System

- BQEnergy presented proposal for a \$9M expansion of solar installation on around 1/3rd total City landfill area to BoAA sub committee, which voted not to recommend this 'no cost' project to BoAA. Review of the Lease Contract will be referred to the City Attorney. Missing the February 2024 auction date puts at risk the opportunity for revenue from the landfill of 25 years of lease payments @ \$50,000/ per year.
- Next auction opportunity is September 2024 for 2025 construction but likely would require finding an alternative solar investor and risk of renewable energy program incentive changes.



EXPLORATORY PROJECTS:

- CT Main Street Center conducted Downtown Derby Program assessment, draft report and recommendations presented for a collaborative project. CT Block Grant being explored with NVCOG and DECD.
- Engineering Feasibility study completed by Luchs Engineering of City of Derby owned land (40 acres) on Fountain Lake indicates 12 prospective commercial locations, which could include a Data center using cost effective renewable energy options, including solar dishes, (10MW) storage batteries and micro grid installed on an Industrial Park

- Assisting a cabinet and sign maker (Connecticut Custom Woodwork LLC relocating from Milford) acquire a 12,000 SF facility on (Roosevelt Drive
- Electriq Power's (EP) Sustainable Community Network
 (PoweredUpDerby) EP is discussion with several Derby businesses,
 including Griffin Health for solar & storage battery programs.
 Requires sub committee and BoAA discussion/apporval in order to
 escrow fees to the City
- Juliani Enterprises seeking to repurpose an historic property on Roosevelt Drive
- Sidewalk rebuild with Griffin Health design proposal funded by Griffin Health (50%) and City of Derby (50%) approved by BoAA
- Yale School of Medicine selected Derby for pilot program
 approved as a community Brain & Heart health project.
- Joint venture discussions with AdvanceCT with an organization seeking to establish a CT International Trade Center.

Please reference the attached list of apparatus currently in service.

The primary concern of the Department is the need to implement a viable replacement plan to maintain a reliable state of readiness of the fleet.

Each apparatus is regularly maintained and is inspected annually in accordance with the National Department of Transportation (DOT) truck inspection standards in addition to all applicable National Fire Protection Association (NFPA) and OSHA standards.

The City of Derby has traditionally replaced fire apparatus between 25 and 30 years from the date of initial service. The most recent standard set forth by NFPA states:

"Fire Apparatus that are older than 15 years should be evaluated for rebuilding in accordance with NFPA 1912 Standard: Standard for Fire apparatus Refurbishing. NFPA further recommends that apparatus more than 25 years old be retired from the vehicle fleet.

Personal Protective Equipment (PPE):

Seventy-Two (72) Sets of Gear purchased with approved ARPA Funds is in process for delivery. We look forward to distributing the gear to our members in the coming weeks.

The following is a report of the activities of the Fire Marshal's Office for the Month of January 2024.

OFFICE TIME:

The following hours include the time the staff (Deputy Fire Marshal & Inspector) put in at the office for staff meetings, training, investigations, writing reports, etc. The total for this month is 50 hours. Fire Marshal's time is 35-hour s a week, split between office hours and field work.

PLAN REVIEWS:

The Fire Marshal's office reviewed 6 different plan reviews spanning from building renovations, cooking hoods systems, fire alarm systems, and sprinkler systems.

PROPERTY INSPECTIONS:

There are 47 properties in various stages of the code compliance process. These include commercial and multifamily housing inspections and reinspection. In addition to sprinkler systems, fire alarm testing, and cooking hoods and suppression systems testing.

Fire Marshal call out: Fire Marshal call outs occur when the fire dispatchers contact the on-call Marshal or Deputy Marshal to respond to an incident usually requested by the fire department. These include fire investigations and other events that may affect life safety systems in an occupancy. The fire marshal's office was called out 7 times during the month of January. In all instances, the call outs occurred on nights and weekends, outside of normal business hours. These events usually require several hours of investigation to determine the origin and cause of the fire or system malfunctions.

Summary:

For the months of January and February of 2024, the Fire Marshal's office has focused on mercantile businesses. More specifically, some of the larger commercial plazas that are in the city. We continue to inspect our multifamily homes as required to be completed annually along with premises requiring various licenses. Mercantile properties are on a 3-year inspection cycle per state statue. Many of our commercial properties have not met those requirements.

Please see the attached year end report which indicates our priorities for 2023 and the goals we achieved.

Fire Marshal's Office

Calendar Year-2023, Year End Report

The City of Derby Fire Marshal's office has responsibility for enforcing local, state, and federal codes to reduce the loss of life and property from preventable fires and other emergencies. This is accomplished through inspection and code enforcement, plan review, public education, and fire investigation services. The Fire Marshal's office maintains a list of Sara Title II Hazardous Materials inventory and properties throughout the city in accordance with the Emergency Planning & Community Right-to-Know Act (EPCRA).

Fire inspections during new construction and renovation projects occur frequently and vary based on the type of construction and occupancy type. During such projects, fire inspections may be necessary at varying points in time totaling dozens of inspections until projects are completed.

Fire Inspections of properties occur every 1-4 years depending on the occupancy type and other hazards. With over 250 Multifamily houses requiring annual inspections, and over 300 commercial properties located in the City of Derby, fire inspections occur every day resulting in the documentation of violations and working with property owners or tenants to resolve the issues.

Most of the time, property owners and tenants seek compliance; however, there are times when legal action must be taken and, in some cases, criminal prosecution is pursued. Ultimately, the City of Derby has the ministerial responsibility to conduct required inspections.

To accomplish this, the Fire Marshal's office consists of (1) full time Fire Marshal, (1) Part-time Deputy Fire Marshal, and (2) Part time Fire Inspectors. However, the department is down 1 Fire Inspector due to a resignment.

During the Calendar Year of 2023, The Fire Marshal's office conducted 184 multifamily home inspections. This represents 73% of the city's total units. Many of these units have not been inspected for several years due to Covid 19 and the limited number of inspectors. Measures have been taken to address these issues, resulting in a higher number of inspections completed in the calendar year 2023.

In addition to our annual housing requirements, the Fire Marshal's offices also completed 46 commercial inspections along with 23 different plan reviews. Plan reviews are required for new construction and renovations of existing structures. Some examples include, building plans, sprinkler plans and hydraulic calculations, fire alarm systems, and commercial cooking hood and

suppression systems. Many of the plan reviews require frequent follow-up and ongoing inspections and testing. Developments such as 90 Main Street and 67 Minerva Street need to be inspected as the construction progresses. This is to ensure that the construction is following the plans submitted.

Finally, the Fire Marshal's office responded to and investigated 14 structure fires in the calendar year 2023. These do not include call outs for smaller fires and other code enforcement issues such as hoarding, smaller fires, illegal apartments, and electrical issues.

Monthly Report

Januarry 2024

The following activities occurred during the month of Januarary:

- Updates to the city's emergency response plan continue. Additionally, annual meetings with the Derby Dam and UI have been scheduled for next month.
- Director Neuendorf attended the regional DEMHS monthly meeting and Dep. Director Lenart participated in a 2-day emergency operations center training last month.
- OEM responded with the fire department and the fire marshal's office to an incident at Griffin Hospital. Interactions with the state department of public health and the hospital's emergency manager took place. Additionally, an after-incident meeting with the FD and hospital administration regarding poor or absent radio communications when firefighters were operating inside the hospital. The FD incident commander reported that he was unable to communicate with his crews' numerous times when they were operating at the scene. The concerns were shared with the fire commissioner and the hospital administration.
- Assistance was provided to the fire commissioner regarding capital requests. Radio tower replacement quotes were requested for both the Cottage St. and Hotchkiss Hose communications towers. Both towers have greatly outlived their life expectancy and are in dire need of replacement. A replacement quote was also obtained for the FD/EMS radio system. The legacy system is 25 years old and is no longer supported by Motorola. Over the last 2 years there have been 30+ service calls made to Norcomm Communications and Frontier to address failures. Additionally, 4 used devices have been purchased to keep the system online due to the lack of available parts.
- Enhanced river monitoring occurred continued during the first 2 weeks of the month due to extensive rainfalls. Extremely high crests were noted on 1/10 at 16.58 feet above flood stage and 1/28 at 11.01 feet above flood stage. The McConney Grove text group was activated during both events with updates to the residents.

- The department recently hired Jonathan Canedo as a recruit police officer. Canedo started the police academy the first week of January, and he is expected to be on the road by late summer/early fall.
- We continue to be understaffed as the nationwide shortage of police officer candidates continues to affect us. We are actively pursuing a lateral transfer candidate or a new recruit to fill our last vacancy.
- The department currently has four out of service police vehicles for a variety of reasons. For the time being two man cars are being utilized when we are at full staffing and cars are not available. We anticipate the return of a front line cruiser within the next month (out of service due to a motor vehicle accident) which will alleviate the two man car situation. Our unmarked cars and auxiliary cars will continue to be an issue until relief is realized via new vehicle purchase.
- The collective bargaining agreement (CBA) between the City of Derby and AFSCME Local 1376 will expire on 30 June 2024. We are hoping to enter into contract negotiations ASAP.
- I have submitted my 2024/2025 budget proposal and my five year capital plan request to city hall. My budget proposal seeks a 1.13% increase over last fiscal year. The priority for the capital plan is police cars, and I have requested four cars immediately due to ignored capital requests during the previous administration.
- You may notice a change in the uniform appearance of our officers as the department is in the process of transitioning to load bearing bullet resistant vests. These vests allow the officers to carry equipment on them instead of their duty belts. Studies have shown that these vests can reduce the incidence of lower back problems as the weight is shifted to the shoulders.



MONTHLY REPORT TO MAYOR DIMARTINO, RE: DERBY PUBLIC LIBRARY

FOR THE MONTH OF JANUARY, 2024

The Derby Public Library is open to the public **55** hours a week, (including 5 hours on Saturdays, year round). The collection consists of over 63,000 items including books, DVDs, CDs, audiobooks, magazines, newspapers, and online databases. Outside book and A/V drops are open 24/7 for people to return their items. There are 3 full-time staff members and a part-time library staff of 9, as well as 2 part-time custodians.

The Derby Public Library is a member of the Bibliomation Consortium which connects us to over 65 other libraries in the state of Connecticut.

The Library building was completed and given to the City of Derby by the Wood Family in 1902 (The library is also known as the Harcourt Wood Memorial Library) and first opened to the public in February, 1903 under the direction of the first Library Director, Grace Child. Last year, we celebrated the 120th anniversary of the library serving the community.


Attached to this report are the newsletters for the library for 2023 which tell of all the activities, programs, and events the library offered. The September/October issue chronicles the restoration, repair, and replacement of the historic front door and entryway of the Library.

Ongoing schedule of class visits from our neighbors, Irving School and St. Mary/St. Michael School continue each week. DRN (Disability Resource Network) consistently includes DPL visits as part of their weekly routine. At start of school year 2022 about 11% of Irving students had library cards, now over 95% have library cards and are active users at the library.

The Library was awarded the Fiber to the Library Communications Grant from the State of Connecticut for \$60,791 to provide high speed internet connections between DPL and CEN.


The Derby Public Library was recognized as one of the first buildings in the City to receive a commemorative plaque by Derby's 300th Borough of Birmingham Historic Signage Project
