## November 8, 2022 State Election

The Electors of the City of Derby are hereby warned to meet at their respective polling places in said city on Tuesday, November 8, 2022, for the following purposes:

- I. To cast their votes for Governor and Lieutenant Governor, United States Senator, Representative in Congress, State Senator, State Representative, Secretary of the State, Treasurer, Comptroller, Attorney General, and Judge of Probate
- II. To vote on the following question for the approval or disapproval of a proposed AMENDMENT to the Constitution of Connecticut, a vote of "YES" being a vote for approval, and a vote of "NO" being a vote for disapproval:
  - 1. Shall the Constitution of the State be amended to permit the General Assembly to provide for early voting?

The full text of such proposed questions with explanatory text, printed in accordance with \$2-30a of the General Statutes, is available at the town clerk's office for public distribution.

The vote on the proposed questions is taken pursuant to the Constitution of Connecticut.

III. To vote on the following local question for the approval or disapproval of certain resolutions approved by the Board of Aldermen/Alderwomen and the Board of Apportionment and Taxation at meetings held August 11, 2022 and August 16, 2022, respectively. The resolutions shall be placed on the ballot under the following headings:

"SHALL THE CITY OF DERBY APPROPRIATE \$3,000,000 FOR THE 2022 ROAD IMPROVEMENT PROGRAM, AND AUTHORIZE THE ISSUANCE OF BONDS AND NOTES IN THE SAME AMOUNT TO DEFRAY THE APPROPRIATION?"

The vote on the above question will be taken under the authority of Section 79 of the Charter of the City of Derby and Section 9-369 of the Connecticut General Statutes. The full texts of the resolutions are on file and available for public inspection in the Office of the Town/City Clerk. Voters approving a resolution will vote "Yes" and those opposing said resolution will vote "No".

Absentee Ballots will be counted at the following central location: Derby City Hall, 1 Elizabeth Street. Election Day Registration will take place for all districts at Derby City Hall, 1 Elizabeth Street

Voting tabulators will be used. The polls will be opened at six o'clock in the morning (6:00 a.m.) and will remain open until eight o'clock in the evening (8:00 p.m.).
