GENERAL STATEMENT OF DUTIES:

The Fire Marshal shall be responsible for compliance with the Connecticut General Statutes Chapter 541 regarding the Office of the Fire Marshal.

SUPERVISION EXERCISED:

The Fire Marshal is responsible for the duties and assignments of the Deputy Fire Marshals, Fire Safety Code Inspectors, Fire Prevention Officer and any other employee(s) of the Office of Fire Marshal.

SUPERVISION RECEIVED:

Works under the direction of the Mayor and/or his designee

EXAMPLES OF DUTIES:

Reports incidents to the Bureau of State Fire Marshal as per Chapter 541 Section 29-305.

Plans, organizes and supervises all fire investigations and inspection activities in the City of Derby.

Responds to all building fires and all serious fires.

Inspects all buildings and facilities of public service and all occupancies regulated by the State Fire and Life Safety Code in the interest of public safety in the City of Derby.

Investigates complaints on violations of state laws and city ordinances.

Issues orders for abatement of fire hazards.

Investigates fires to determine origin and cause.

Organizes and directs programs to develop public cooperation in the prevention and control of hazardous conditions.

Prepares reports on inspections and investigations and makes recommendations regarding matters within the purview of his/her authority.

Inspects tanks storing hazardous or combustible liquids or gases and/or tank trucks. Issues and checks explosives permits, licenses and sites.

Performs inspections of all occupancies within the City of Derby that fall under the requirements for inspection in accordance with Connecticut General Statutes and applicable regulations.

MINIMUM QUALIFICATIONS, KNOWLEDGE, SKILL AND ABILITY:

Thorough knowledge of modern fire investigative techniques and fire safety, prevention and protection practices.

Ability to read and interpret regulations and procedures.
