Items were removed from the original project because KBA was \$1.4 million off on their quote.

Mr. Cota said they are working on the job descriptions and budget. They have estimated it will cost \$81,000-82,000 per year. The budget would include a head custodian, assistant custodian, and attendant. Those positions would be part-time at approximately 20 hrs each per week. Equipment maintenance, 4 phone lines, internet, office supplies, HVAC, water and heat were included in the budget. Mr. McLiverty said they need to add sewer fees to the budget. Mr. Cota said he'd look into that.
