Board of Aldermen/Alderwomen Meeting Minutes Derby City Hall 1 Elizabeth Street, Derby, CT June 13, 2019

#### **1. Call to Order.** Mayor Dziekan called the meeting to order at 7:00 PM.

#### **Decommissioning Derby Fire Alarm Call Box Response System** June 13, 2019

WHEREAS, call boxes were installed throughout the City about a century ago for the purposes of creating a public safety system for emergency service and fire suppression response (the "Call Box Response System");

WHEREAS, the Call Box Response System is expensive to maintain, creates an attractive nuisance for vandals, and has become obsolete and replaced by modern mobile technology;

WHEREAS, the Derby Fire Department houses do not rely on the Call Box Response System for communication purposes and that system is considered retired; and,

WHERAS, the City of Derby wishes to decommission the Call Box Response System, remove all of its call boxes from public areas, inventory each removed call box by box number, and to secure the inventoried call boxes in a secure location maintained, owned and controlled by the City of Derby,

NOW, THEREFORE, BE IT RESOLVED that the Call Box Response System is hereby decommissioned. The Fire Commissioner is hereby authorized to cause the removal of all remaining call boxes from all public areas and cause each removed call box to be inventoried by call box number. The Fire Commissioner is further authorized to secure the inventoried call boxes in a secure location maintained, owned and controlled by the City of Derby.
