Approval of Minutes – Meeting for June 6, 2019

A motion to approve the minutes of the June 6, 2019 meeting was made by Mr. Pacheco and seconded by Mr. Lisi. Motion Carried.

Additions, Deletions, Corrections

Ms. Fusco added under Old Business 7e. Update on Barron Building

Ms. Fusco added under New Business 8a. Surveyor: Nowakoski, O'Bymachow, Kane & Associates (estimate attached) to stake property line for 356 Hawthorne Avenue, left side of Stygar property.

Ms. Fusco added under New Business 8b. Request to move the DHA meeting date of August 1, 2019 to August 8, 2019.

Public Portion

No one spoke from the public.

Old Business:

- a. Discussion of Status of all of all Grants
 - 1.) SSHP; Letter attached

Ms. Fusco advised that the letter seems to indicate that this is not going to happen and at this point even if they did open up the grant, Mr. Tink has not been in contact, so they would not be prepared to submit an application.

2.) Critical Needs:

Ms. Fusco explained this hasn't gone anywhere to date. Ms. Fusco still has to contact Tom Arcari and will report back to the board once she has spoken with him.

3.) Should hear on Small Cities Grant @ end of 7/19

Ms. Fusco said they have not heard anything to date on the Small Cities Grant but are expected to hear by the end of this month.

b. Section 8 Waiting List opened on July 3, 2019; Letter attached

Mr. Henderson explained that the Section 8 Waiting List opened on July 3, 2019 at 9:00 am and by 9:11 am 580 applicants had applied. The first 500 applicants were selected and Mr. Henderson was pleased with how well the website and the online application process worked. He added that there are a few issues that will need to be worked out but the website and electronic process worked out very well.

c. Discussion & Possible Action on Personnel Policy and an Adequate Performance Evaluation Tool.

Mr. Lisi said before the board votes on the Personnel Policy, he would still need to meet with Ms. Ducharme. He also added that they would need some input from the board on some points within the document. They should be ready to vote on the Personnel Policy by the October meeting.

d. Reopen discussion on Procurement of new auditor.

Ms. Fusco said the RFP was posted on July 1, 2019 and closes July 31, 2019. She added there are five firms that have expressed interest. Ms. Oczkowski added that the audit needs to be submitted in September and doesn't think that will be enough time to get the audit submitted. Ms. Fusco said the current auditor did not apply so they might need to find a new auditor and apply for an extension.

e. Barron Building Update.

There was a lengthy discussion regarding the Barron Building, which now is narrowed down to only seven units in the building that need a remediation plan. The board also discussed the possibility of the building coming back to the Derby Housing Authority if the building is not fixed. Ms. Fusco said she would speak with the attorney to see what their options are at this time.

New Business:

a. Discussion & Possible Action on Surveyor: Nowakoski, O'Bymachow, Kane & Associates (estimate attached) to stake property line for 356 Hawthorne Avenue, left side of Stygar property. There was a lengthy discussion regarding the trees on the Derby Housing Authority property that boarder the left side of the Stygar Property. Over grown trees are causing problems to the building and grounds and could potentially cause more damage going forward if the trees are not cut and cleared. Ms. Oczkowski added that the UI has already been out and done their part. Since no one is certain of whose property the trees are located on Ms. Fusco asked Mr. Henderson if it was possible for him to get two more bids to procure the property so that the board could make a better decision once they had more information based on the surveyor.

Mr. Lisi made a motion to procure two additional estimates to stake property lines at Stygar Terrace. Mr. Pacheco seconded the motion. Motion Carried.

b. Discussion & Possible Action to move the DHA meeting date of August 1, 2019 to August 8, 2019. After some discussion it was decided to move the August meeting to August 8, 2019.
