S. Buda stated that he has some concerns above erosion on the bank at Two Mile Brook and felt that debris that is in the brook is a result of the erosion. R. McEvoy stated that he went to the site and reviewed conditions. He stated that the erosion is actually within the Town of Orange and only certain elements are under the jurisdiction of this Agency. He stated that in the short term the owner can request permission from the WEO to authorize approval for removal of the trees or at least cut down. The bank needs to be stabilized which is also outside of the jurisdiction of Derby. P. Padilla moved that C. Sarmiento be authorized to administer authority to have the brook stabilized. The motion was seconded by J. Miller and carried unanimously.

P. Padilla moved to approve the payment of the following invoices from Millone & MacBroom – Inv. #92777 \$625.00 and Inv. #92776 \$454.90. The motion was seconded by J. Miller and carried unanimously.
