- -Commissioner Lenart motioned to approve the "Helping from Heaven" 1st annual motorcycle ride and Commissioner Bartholomew seconded and the motion carried.

Chief Narowski briefed the commission of ongoing parking and pedestrian issues regarding the HOPS Company.
