# D. 23 Factory Street – Parcel 8-3 & 8-5 179 Derby Downtown LLC – Application for a Site Plan Approval for 215 residential units and first floor commercial space.

Also noted, that the timeline of approvals must be consistent as per the regulations and the timeliness of the other applications will be considered in the order that is required.
