A special meeting of the Derby Board of Police Commissioners was held on September 4, 2018 at The Derby Police Department, 125 Water Street, Derby, CT

The meeting was called to order at 6:00 P.M. by Commissioner Pollastro.

1. Pledge of Allegiance

2. Roll Call

Present were Commissioners Pallastro, Lenart and Mancini. Also present was Chief Narowski and Deputy Chief Todd.

Deputy Chief Todd briefed the commission on two concurrence requests for traffic impact studies regarding the Big Y supermarket on New Haven Avenue and a coffee shop on Pershing Drive in the Red Raider Plaza. Deputy Chief Todd recommended the Commission concur with the Big Y request. Commissioner Pollastro motioned to approve Big Y and Commissioner Mancini seconded and the motion carried. Commissioner Lenart motioned to table the coffee shop concurrence until further information is received and Commissioner Mancini seconded and the motion carried.

11. Executive Session

Commissioner Pollastro motioned to enter into executive session and invite Chief Narowski and Deputy Chief Todd. Commissioner Lenart seconded and the motion carried at 6:26PM.

The meeting reopened to the public at 6:46PM.
