A motion to approve the minutes was made by Mr. Malerba and seconded by Mr. Carloni. Motion Carried.

Treasurer's Report

There was no Treasurer's report.

Budget Procedure, Status and Advisory

No one had any information on the budget.

Transfer Fire Department \$5,717.80

- From Account (001-3200-330-0332)) Building Maintenance \$4,217.80
- To Account (001-3200-270-0275) Ladder Test \$4,217.80
- From Account (001-3200-440-0440) Engine Pump \$1,500.00
- To Account (001-3200-330-0334) Equipment Maintenance \$1,500.00

A motion to make the changes was made by Mr. Butler and seconded by Mr. Pollastro. After much discussion, the board decided to move this request to the next meeting. Ms. Szewczyk will ask Mr. Petrino to send and email giving the explanation as to why the ladder test cost has increased, the board needs invoices for all the expenditures, and is this ladder test an annual thing, and should this expense be in it's own line item or this be part of equipment maintenance. The board felt they need this information to have a better understanding ongoing in the budget process.

Blight and Density Reduction, Appropriate \$50,912.55

A motion was made by Mr. Carloni and seconded by Ms. Miani. Mr. Coppola explained that the money was needed to recognize sales of blighted property and to pay blight related expense. Motion Carried.

A Motion was made by Mr. Pollastro and seconded by Mr. Malerba to pay the invoice from Jostens for 25 State Championship rings for the tract team. Mr. Malerba asked who authorized the purchase of these rings, and he thought after the discussion last month that this would not happen again. The board failed to pass this motion, and asked for an explanation as to who authorized this purchase. Motion Failed.
